1. PRICES AND SPECIFICATIONS

Prices, specifications and equipment are subject to change with reasonable notice, as solely determined by Erwin Hymer Group NA. Erwin Hymer Group NA shall sell its vehicles at prices in effect at the <u>date of delivery</u> from Erwin Hymer Group NA and in accordance with their standard dealer price list, <u>REGARDLESS of when the vehicle is ordered</u>, with one exception: vehicles for which the <u>order date and</u> <u>original due date are prior to the effective date of the price change</u> can receive, at the Dealer's request, the prices and model year in effect as of the original due date. If these prices are higher than those in effect when the vehicle was ordered, Dealer may cancel the order without obligation. (This policy protects both Erwin Hymer Group NA and Dealer from unexpected price increases beyond their control). Prices of the standard features and options of the selected model are valid only at the time of initial manufacture. Prices of options are in addition to substituted items where applicable. Production scheduling is subject to availability of chassis. materials, labour and other necessary services as determined solely by Erwin Hymer Group NA.

2. PAYMENTS AND OTHER CHARGES

In the event that Dealer does not, for whatever reason, finance the purchase of the vehicle through Erwin Hymer Group NA, then all payments, along with any other charges due in accordance with any such purchase, are to be paid at the earlier of the time when the vehicle is delivered to, or for Dealer, or when transfer of ownership document, known in United States as a Manufacturer's Certificate of Title or Certificate of Origin or Statement of Origin, is presented.
